


Each month, the City of Pigeon Forge collects a one-percent gross receipts tax from all businesses in Pigeon Forge. This tax is then tracked and reported by industry sector, providing the opportunity to monitor upward and downward trends.

Provided the thriving mixture of tourism attractions, lodging properties, restaurants, retail services, and other businesses, Pigeon Forge is not overly dependent on any single sector. This is showcased in the revenue reported by the city as it tracks what is generated by each business sector.


In 2022, Pigeon Forge experienced a 1% increase in gross revenue. This record-high comes just a year after 2021's record-high, crossing the two billion dollar threshold for the second consecutive year.
